




- District is financially sound with:






- Operations: \$1,250,956
 - District Overhead: \$615,553 (49%)
 - Operations Division: \$405,430 (32%)
 - Training Division: \$82,245 (7%)
 - Prevention Division: \$147,728 (12%)

- Salaries and Benefits
 - 36% of total budget







- Operating Reserve
 - **\$600,000**
- Capital Reserve
 - Building for purchase of Ladder in 2020
 - Current annual contribution sufficient for long term plan
- Contractional Reserves





Increased Equipment Capabilities




- Nozzle standardization project

 - Updated hose loads to enhance performance for our jurisdiction
- Upgrading apparatus
 - Retired Engine 1 (1983) and Engine 2 (1976)
 - Put into service new Engine 1 (2017)

- Migrated occupancy database to Emergency Reporting
 - Enables database to be updated from the field
 - Identified redundant or out of date occupancies
- Inspections Completed
 - 449 Inspections
- Plan Reviews & Permits
 - 124 plan reviews completed
 - 59 permits issued
- Targets less than projected due to staff changes







- Hire Fire Marshal and Inspector

- Risk and prioritize all occupancies
