**OLD BUSINESS**

**Station Transfer:** Wolf, Lancaster, Walker met with representative from Senator Bennett Office Transfer for fire station may be possible, but exploring options

**Strategic Planning:**

Chief Wolf presented a PowerPoint of where we are now compared to when the original strategic planning meeting was held in October of 2017. Highlights include the increased participation of our members, recruitment dinner yielded positive results and new members, residency program went live in May. The prevention division is fully staffed now with a Fire Marshal and Fire Inspector, Plan review fees were put in place 1/1/18, Impact fees go live 7/1/18. We are pursuing project WUI work to be facilitated by a volunteer.

**De-Gallagherizing Options**

Chief Wolf reviewed with the board what Gallagher is and how the Residential Assessment Rate impacts our revenue from property taxes. The benefit of de-gallagherizing is that it would take us from a fixed mill levy to a fixed revenue.

The board discussed possible ballot language for de-gallagherizing. The board concluded that, yes, we should put a question on the ballot for this fall. The language is still to be determined. We are unsure at this time if any other local special districts will be on the ballot.

**NEW BUSINESS**

The board was presented with the Impact Fee and Plan Review waiver policy that was originally presented on March 28<sup>th</sup>, again on 4/18, and with revisions on 5/23. Moved by Mike Kearney, seconded by Mike Richardson to approve the Impact Fee Reduction/Waiver Policy and Plan Review Fee Reduction/ Wavier Policy as written. Motion carried unanimously.

The next regularly scheduled board meeting will be June 27, 2018 at 4:00 p.m. at Dannels Fire Station.
