REPORTS

Fire Chief Report –

The ASU CORE heart screening took place on Saturday with 15 people participating.

The command vehicle is currently at Recreational Electrical with an estimated time of delivery to be around 7/1. They are still waiting for the center console and the truck box.

The station flood repairs are almost complete, with just a few small projects to complete. We are still receiving bills for work performed.

The Chief transition is on track.

Chief Wolf will be attending a meeting on Thursday on emergency response during the Highway 34 closure.

The Open House planning for 7/1 is well underway and on task.

Chief Wolf will be starting employee meetings this week.

Treasurer Report – Treasurer Richardson reviewed the May 2016 balance sheet(s) including, but not limited to: governmental funds and schedule of capital assets, statement of revenues, expenditures, and changes in fund balance for general operations, operating reserve, Tabor and capital reserve were also provided.
